RESOLUTION APPROVING THE TITLE VI FARE INCREASE STUDY OF THE NASSAU INTER-COUNTY EXPRESS BUS COMPANY

November 20, 2025

WHEREAS, Section 209(3)(a) of the Nassau County Charter (the "<u>Charter</u>") established the creation of the Nassau County Transit Committee (the "<u>Committee</u>") to review the budgets, fare structures, fees, and services proposed by the contractor that operates the Nassau Inter-County Express ("<u>NICE</u>") bus service; and

WHEREAS, Transdev is currently the contractor that manages, operates, and maintains the NICE bus service; and

WHEREAS, the NICE bus service has proposed a fare increase (the "Fare Increase"); and

WHEREAS, a Title VI Fare Increase Study is an analysis required under Title VI of the Civil Rights Act of 1964, which prohibits discrimination based on race, color, or national origin in programs or activities receiving federal funding, including public transportation agencies that receive funds from the Federal Transit Administration (the "FTA"); and

WHEREAS, NICE is a recipient of federal funding from the FTA and thus requires a Title VI Fare Increase Study due to the proposed fare increase; and

WHEREAS, the purpose of the Title VI Fare Increase Study is to determine whether a proposed fare increase imposes disparate impacts on minority populations and / or imposes disproportionate burdens on low-income populations; and

WHEREAS, Transdev staff has prepared a Title VI Fare Increase Study for the NICE bus service (the "<u>NICE Title VI Program Plan</u>") that was reviewed by the Committee at the public hearings that occurred on November 13, 2025 and November 20, 2025 (the "<u>Meetings</u>") now therefore, be it

RESOLVED, that the Committee hereby [approves/disapproves] the NICE Title VI Fare Increase Study, in the form presented to the Committee at the Meetings.
